CHAIRMAN'S REPORT

Over the last year Auckland Bowls has continued working on significant strategies and policies for promoting and developing the sport of bowls in Auckland.

Clubs and Club Development.

The future of the sport is in the hands of those clubs which have Executives focussed on their future development plans using additional resources and assistance from Auckland Bowls.

Auckland Bowls role is to work with clubs to listen and learn from each other; share our perspectives and resources; agree ways of collaborating and become very successful in having sustainable clubs.

One of the main measures of our success is the retention of existing members and growing the involvement of casual participation in the sport. In the 2017/18 year the number of playing members in Auckland has dropped from 2576 to 2478, the number of non-playing members has risen from 2001 to 2688 and the number of casual participants has risen from 17,189 to 25,187. It is good to see the increasing effort that clubs are putting into welcoming casual participants into the sport. To be able to provide these programmes for casual players, it is essential to maintain strong club membership numbers.

The development of club agreements with Auckland Bowls has been a learning experience. Where clubs have a clear plan for their way forward it has been possible to get joint agreement quickly. It is sad but true that some clubs readily recognise they have no ability or desire to do anything other than continue until their volunteer or financial resources run out. However, there is a big opportunity for continuing development in willing clubs.

The Rawhiti Bowling Club was a shining light in setting up the Rawhiti Committee with Auckland Bowls that allows resources to be provided to help clubs take up the opportunity to become stronger over the next few years. On the other hand we have clubs that fritter away significant assets through poor management. They don't want to recognise they can (and need to) obtain the right sort of help. Auckland Bowls hopes that clubs, particularly those with significant property or financial assets, will consider how they can use their assets and abilities not just for their own club members but also for the development of our sport in Auckland.

Apart from our major initiative in budgeting about \$2.3m over the next four years promoting club development

with the help of the Rawhiti Committee, another similar amount has been set aside for supporting the establishment of covered green facilities. We plan to commence discussions with clubs where enclosed greens might be provided.

They could then promote to their members the outstanding financial results Auckland Bowls achieves which enables us to share significant resources with collaborating clubs.

The Board members spend a lot of time and effort on solutions to the challenges Auckland Bowls face. It is a pleasure to work with such a devoted team.

We also have a great group of supporters I want to thank - too many to name personally.

I want to especially thank Rostyn Jones for his guidance as he retires from chairing our Finance Committee. The Umpires Association continues to ensure our many events are expertly controlled. We value the contribution from members of the Rawhiti Committee. We also congratulate members of the Kimberley Committee for achieving outstanding results this year.

Also I wish to thank each member of our small management team. Phil Vyver, Steve Clifton, Mia Smith, Kristina Fry and Paul Tuckley who have all made valued contributions over the year.

PRESIDENT'S REPORT

This is my first year as president of Auckland Bowls and I have much pleasure in presenting the following report for the 2017-2018 season.

The year has gone very smoothly for both bowls administration and players. Auckland bowlers have enjoyed a year of good weather, good greens and the provision of one covered stadium used for finals when weather has been inclement. We have seen the amalgamation of two Clubs and plans for several covered stadiums. We look forward to seeing and playing in these covered stadiums in the near future.



The Auckland Representative teams have played well and the 1-8 year Women's team are to be congratulated on winning the National title. Another National title went to the Carlton Cornwall Division 2 Women's team. Our Representative Open Teams sported new uniforms at the National Intercentre finals in Christchurch and put up good performances there. The Trusts New Zealand Open was another successful tournament this year with the finals being televised. Auckland players were prominent on the finals day winning three of the six events. Auckland has some very promising young and junior bowlers who should be the leading players in the Auckland Representative sides in the future. At the beginning of the season The Premier Women's Open Singles was another well contested affair. The Tournament had a change in format and went well for those who played on the finals day.

I have travelled to several other New Zealand centres playing bowls this year. All Clubs have the same problems of falling membership etc. However, the camaraderie and competition amongst bowlers has not died. Those who play the game are enjoying themselves. However, many Clubs are living in the past rather than looking forward to where the game of bowls will be in the future. These Clubs and their

members are being selfish and slowly killing the game. They are not open to new ideas and do not want to change their comfort zone. We need to be able to convince some Clubs that amalgamation can only be good for the game. Clubs need to work together to keep the game alive.

The new playing programme for next season looks very exciting. The new B3Five competition will be innovative and hopefully exciting to play. It is good to stimulate interest in the game with new formats. Winter interclub starts soon so there is not much time before the year is underway again! The National Singles and Pairs are in Auckland in the New Year and we encourage you all to support this exciting tournament.

I personally would like to thank all those Canoe and Campi Cup coaches who work tirelessly through the winter in all kinds of weather coaching the juniors in their zones. These coaches are looking after the new members of your Clubs. Please support them and carry on their good work by playing with these new players. These are the people who will be the future of your Club. Treat them well.

I would also like to thank the Umpires and Convenors who look after our championships. You do a great job, sometimes under very difficult circumstances. Keep up the good work. Finally, I would like to thank all the volunteers who work so hard for our Clubs. Without you the game of bowls would suffer greatly.

The Board has achieved a lot for Auckland Bowls this year. Thank you for a job well done.

GENERAL MANAGER'S REPORT

The Auckland Bowls Strategic Plan outlines the direction for Auckland Bowls. It includes six key outcomes to be achieved by 2020. A summary of progress to date is as follows:

Growth	2017 – Base Figures and Target <i>More than 10% growth in overall non-playing members and casual participation as measured by the annual club returns over the three-year period (base: 19,190 participants) and maintain the current level of Playing Members (base: 2,576).</i>
	2018 Update - Non-playing members and casual participants total 27,875. An increase of 45% well ahead of the 10% target. Playing Members total 2,478. A decrease of 98 members or 3.8%. This is below the maintain target.
Club Network Plan	2017 – Base Figures and Target <i>Plan implemented with nine club group plans in place and fully operational, with at least three covered greens completed.</i>
	2018 Update - Three have been operational for the last year to a certain extent. These will be reconfirmed along with a further three groups, to have six groups in place by 31 July 2018. Covered green project underway in 2018-2019.
Events Programme	2017 – Base Figures and Target <i>Events Programme in place that caters for both traditional and new participants with more than 80% satisfaction rates.</i>
	2018 Update - Based on survey results we have an overall satisfaction rate of 89.5%. This drops to 57.7% when including only those that are very satisfied or extremely satisfied.
Systems	2017 – Base Figures and Target <i>Fully operational database in place with 100% of total members and 25% of participants on the database.</i>
	2018 Update - Research project completed, and a preferred supplier has been established. Targets in place for 2018-2019 and the project is now underway.
Succeed	2017 – Base Figures and Target <i>Top three ranked Centre in Bowls NZ Intercentre Events.</i>
	2018 Update - In 2018 Auckland is ranked fourth. When considering the results over the past three years, we are second.
Governance	2017 – Base Figures and Target <i>Achieve and maintain sector governance quality mark.</i>
	2018 Update - Initial Governance review has been undertaken and a schedule of improvements to be implemented in 2018-2019.

FINANCE

An operating loss for the year of \$11,850 has been recorded. When the cost of depreciation and income from the Kimberley Investment Fund is added, an overall surplus of \$95,372 has been achieved.

In line with the Strategic Plan expenditure has increased significantly for Club Development and Support, with an additional \$123,948 being spent in this area when compared to 2017.

Events and Tournaments is the next largest area of expenditure with \$236,067 being spent, up slightly on 2017. Together these two areas make up 64% of total expenditure.

Club Levies make up just 5% of total income and have been entirely allocated to Events and Tournaments. The remaining 95% of income is generated through areas such as grants, sponsorship, interest and entry fees.

The Balance Sheet remains very strong. The funds held and managed by the Kimberley Investment Committee (see separate report) continue to grow at a steady rate, with an impressive 16% return for the year.

THE TRUSTS NEW ZEALAND OPEN 2018

The event was once again a great success with many bowlers from throughout New Zealand converging on the greens of Auckland for nine days of bowls. Unfortunately, the weather once again played a major part in proceedings. With careful management and support from the players we were able to finish the tournament on schedule.



The Trusts New Zealand Open takes a break in 2018-2019 season but we hope to be able to schedule a revised event for the following season. Thank you to Blockhouse Bay Bowls and all the other clubs that have provided greens and volunteers to make the tournament a great success over the years.

UMPIRES

Thank you to each and every umpire that has officiated over the past year. Whether it be once or many times your support is greatly appreciated! Put simply we could not run our events without you!

More umpires are required however, and I know this is an area that the Umpires Association has been working on. If you would like to be an umpire or measurer then put your hand up and get involved! There is a pathway that can lead you right through to officiating at World Bowls if that is what you want to achieve.

EVENTS AND OPERATIONS COMMITTEE

To the Operations Committee members, Chairperson Jill Fraser, Helen Blick, Paulene Murdoch and Mia Smith, Auckland Bowls Events Manager, a very big thank you for your assistance in the running of all the events this season and for your support and expertise whenever required.

The season saw 2,113 (2017: 2,188) entrants in Auckland Bowls run events for a total of 5,297 (2017: 5,419) participants. This is a slight decrease on last year with the main contributor a decrease in entries for the Club Championship Events. We hope to receive greater support from clubs for these events next season.

Thank you to the staff of Auckland Bowls, Mia Smith, Kristina Fry, Paul Tuckley and Steve Clifton for your hard work throughout the year. I would also like to thank Cynthia Morris, Alastair McKenzie and Darren Schroeder who

Legal Name of Entity: Auckland Bowls Incorporated

Type of Entity: Incorporated Society - No 222253

Entity's Purpose:

Auckland Bowls is the regional governing body for lawn bowls and is committed to delivering a sport that is enjoyable, entertaining and accessible to the people of Auckland and visitors to our region. We are committed to more people playing Bowls more often.

Entity's Mission:

Lead and develop the growth of Bowls in Auckland

Entity's Structure:

Auckland Bowls is governed by a seven person Board, with the President and Vice President elected by the members; and five independent Board Members recommended to the AGM for appointment by the Selection Panel in accordance with the Constitution. Auckland Bowls currently has a staff of four fulltime and one part-time person, who are based at the office at the Mt Eden Bowling Club.

Main Source of Income:

Income is generated in the main through membership fees, grants, sponsorship, contracts and event based activity.

Entity's Reliance on Volunteers and Donated Goods or Services:

Like many not-for-profit organisations, Auckland Bowls is dependent on volunteers who assist with all facets of delivering the sport to the members and participants. Without these volunteers the organisation could not function.

Description of the Entity's Outcomes:

Auckland Bowls is responsible for the administration, promotion and development of the Game of Bowls within its defined boundaries. This includes providing support services for its affiliated clubs; events and tournaments for members and visiting participants; and to promote and grow the sport.

Description and Quantification of the Entity's Outputs:

Auckland Bowls has a combined membership and participation base of 30,353 (2017: 21,766). The total number of entries in Auckland Bowls run events was 2,113 (2017: 2,188), for a total of 5,297 participants (2017: 5,419).

Additional Information

Auckland Bowls was first established in 1896 and has 42 affiliated clubs (2017: 45). It covers the area from the Auckland Harbour Bridge in the north to Papatoetoe in the south; from Piha in the west to Maraetai in the east.

1. STATEMENT OF ACCOUNTING POLICIES

GENERAL ACCOUNTING POLICIES

The measurement base adopted is that of historical cost. Reliance is placed on the fact that the business is a going concern.

Auckland Bowls Incorporated has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses of equal to or less than \$2,000,000. All transactions in the Financial Reports are reported using the accrual basis of accounting. The Financial Reports are prepared under the assumption that the entity will continue to operate in the foreseeable future.

Specific Accounting Policies

The following specific accounting policies which materially affect the measurement of financial performance and financial position have been applied.

(a) Valuation of Assets

Fixed Assets have been recorded at cost less accumulated depreciation.

Listed investments have been recorded at market value (refer notes 5 and 6). Movements in market value of listed investments are reflected in the Investment Revaluation Reserve. Other investments are valued at cost plus accrued interest.

Accounts Receivable have been recorded at estimated realisable value. Where a debt has been considered irrecoverable, it has been written off in the Statement of Financial Performance.

(b) Depreciation of Fixed Assets

Fixed Assets have been depreciated on a diminishing value basis over the expected life of the asset with the exception of Leasehold Improvements which are being depreciated over the anticipated term of the tenancy lease.

(c) Goods and Services Tax

All amounts are recorded exclusive of GST, except for Debtors and Creditors which are stated inclusive of GST.

(d) Tax

Auckland Bowls is an Incorporated Society and an amateur sports body and has been granted exemption from income tax by Inland Revenue under Section CB 4 (1) (h) of the Income Tax Act 1994.

(e) Leases

Operating lease payments, where the lessors effectively retain substantially all of the risks and benefits of ownership, are included in the determination of the net surplus in equal instalments over the lease term.

(f) Changes in Accounting Policies

There have been no changes in accounting policies during the financial year.

At an SGM of the Rawhiti Bowling Club (RBC) on 28th September 2014 the members resolved to transfer certain assets (\$5,413,867.92) to ABI to establish a Fund to be known as the Rawhiti Fund. The Rawhiti Fund is administered by ABI in accordance with the Deed of Agreement made between RBC and ABI dated 11th May 2015.

At the same SGM a separate sum of \$1,109,997 was set aside for specific grants to be given to clubs where members of RBC had joined. ABI is managing these funds on behalf of RBC. Under the agreement ABI received an initial fee of \$7,000, plus the ongoing interest whilst the funds remain under ABI management. Following distributions to approved clubs the fund balance is \$0 (2017: \$8,400).

KIMBERLEY INVESTMENT COMMITTEE REPORT

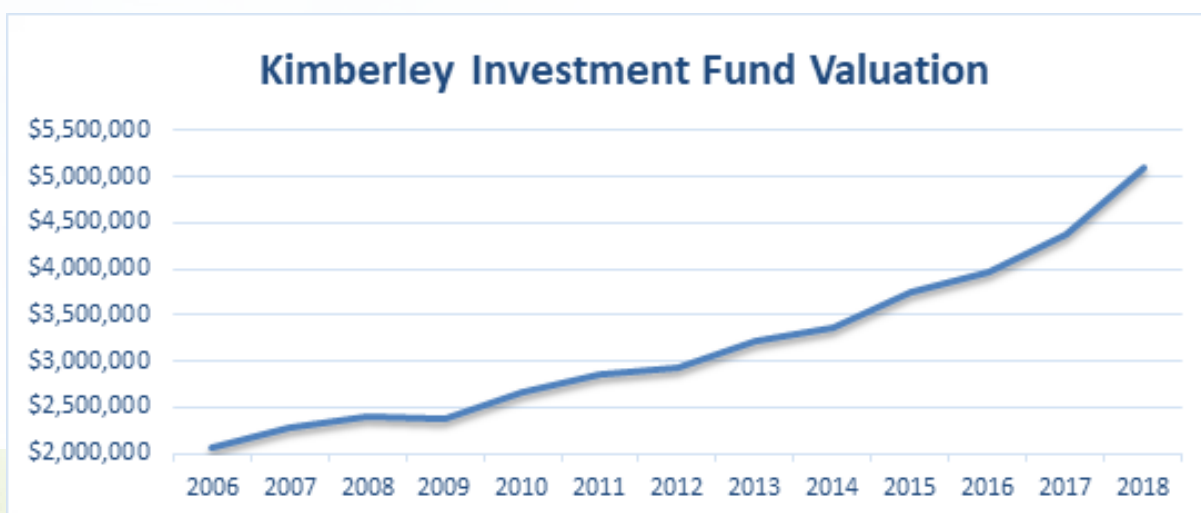
In 2006 Auckland Bowls received \$2,065,000 from the sale of its Kimberley Road property. The Kimberley Investment Committee was then set up and consists of Graeme Bennett, Bob Croker, David Timms and Hadden Vernon. Members are appointed by the Auckland Bowls Board for a two-year term, with a rotation policy in place where two people are eligible for reappointment each year.

Graeme Bennett is standing down from the committee this year and will be replaced by Gavin Brown. I would like to take this opportunity to thank Graeme for his valued contribution to the committee since its inception. Graeme's knowledge, experience and guidance has been an important component to the success of the committee.

The funds have a current market value as at 30 April 2018 of \$5,096,573. This represents an increase of 16.33% on last year (\$4,380,908). In accordance with the Statement of Investment Policies the portfolio has been diversified and now includes:

RAWHITI FUND COMMITTEE REPORT

Following the sale of the Rawhiti Bowling Club a Deed of Agreement was signed by Auckland Bowls and the Rawhiti Bowling Club. As part of the Deed a Rawhiti Fund Sub-Committee was set up comprising two members appointed by the Rawhiti Bowling Club, three members appointed by the Appointments Panel.

The current members of the Rawhiti Fund Sub-Committee are Graeme Bennett (Chairman); Bruce Anderson; Michael Feek; Rod College and Gerard Hulst (Rawhiti appointments).

As at the 30th April 2018 the fund is \$5,574,707 (2016: \$5,577,048) after allowing for income and expenditure.

In line with the Deed the funds are being used to develop the sport in Auckland. To date, \$309,000 has been allocated, with the bulk of funds going directly to clubs to develop and promote the sport at a local level. Additional funds have been spent by Auckland Bowls to market the sport on behalf of all clubs.

Five clubs have benefitted from funding in the first year of Auckland Bowls setting up Club Development Agreements. This has been a learning experience for all concerned, with new agreements currently being negotiated. By the end of the 2018-2019 season most clubs in Auckland will benefit from this funding, through Group Club Development Agreements.

Following an initial allocation of \$2.5m for Club Development Agreements (over five years) the remainder of the fund has now been tagged to specific projects. These projects will be outlined in more detail at the AGM and includes a significant investment in viable covered facilities. We are excited by the opportunities provided by this fund and we look forward to being able to support clubs in the coming year.

The funds are held in term deposits as outlined in the Deed of Agreement with the risk spread across three banks. This provides a low risk income for the fund, that in time will be spent on club development projects.

Thank you to my fellow committee members for their commitment and I look forward to working with you again in 2018-2019.
