# SUSTAINABLE CLUB NETWORK

Auckland Bowls is here to support Clubs, and with the Rawhiti Fund, we have been extremely fortunate it enables practical financial support to Clubs for various projects: increasing club profiles and delivering membership initiatives through the appointment of Bowls Development Officers (BDO's). Clubs will need to look at ways to retain the services of a BDO once their funding term has completed.

Many Clubs continue to add value by utilising grants to improve club facilities. The Rawhiti Fund has this year made payments to Clubs of \$690,000 for Club Development Agreements (CDA's) and project enhancements. In addition, a further \$1,184,000 has been committed for planned projects such as CDA's, artificial and covered greens and enhanced facilities.

We are excited by the prospect that within the coming season, we should have five Clubs with a covered green. Construction is underway at Papatoetoe Hunters Corner and shortly at Howick with two covered greens. Both these projects are made possible by contributions from the Rawhiti Fund.

In addition, Royal Oak is proposing to open their covered green before summer - add the existing covered facilities at Remuera and New Lynn, these will be a boost for the Clubs by providing an opportunity to introduce new participants to the game of bowls.

# **GROWTH IN PARTICIPATION**

Last season we saw an 13% increase in full playing membership. This wasn't so for this season, Clubs reported members were deferring their membership renewals until players got certainty of Clubs re-opening and the easing of the pandemic conditions.

One focus for Auckland Bowls is to develop and promote tailored offerings that will increase membership. With so many demands on people's time, we need to look at formats that will engage Clubs to cater to participants at all levels - we need to get them along to play.

# **OUR APPRECIATION**

I would like to take the opportunity to thank and acknowledge David Ball and his team for the management of Auckland Bowls during a challenging year, thank you for your efforts and support.

To the Board, my thanks for your work and support throughout the year, we look forward to your ongoing contribution. Our President Greame Scott is standing for another term, you will see him again around the greens when Centre events are in progress. This year we welcomed Sky Sports broadcaster Rikki Swannell to the Board. Rikki's skill set will be an asset to Auckland Bowls. As Michael Feek has chosen not to reapply for the Board, it is important we acknowledge his many years' service to Auckland Bowls.

# **GENERAL MANAGER'S REPORT**

Our resolve was tested again, but we can take heart that the resilience and spirit of our bowling community remained intact during Covid – we proved that anything is possible when you have a cando attitude. Covid gave us a new normal, although what that looks like is different for every person. Our Clubs showed resilience as they managed the impacts of Covid – the bowling fraternity jumped into action, steering through new procedures to provide a safe environment for their members and visitors. Club executives and members rallied together to get their members back on the greens and complete their club competitions for the season.

As we progress through 2022, there will be new challenges for us to face. Russia's invasion of Ukraine has created material uncertainty across the globe. These and other factors are creating financial pressures on our households and communities. Clubs will face increases in supply costs and members will be tackling higher costs of living.

# **SEASON HIGHLIGHTS**

We want to acknowledge and celebrate all the many achievements during our bowling season – here is just a snapshot:

- Olivia Bloomfield and Paris Baker from New Lynn Bowling Club win 2022 Australian Open Women's Pairs
- Glen Eden Bowling Club celebrates 100 years
- Mike Galloway and Tony Grantham are selected to the Blackjack squad to compete in Commonwealth Games in Birmingham
- Carlton Cornwall Bowls makes history with their Women's teams taking a clean sweep of the Auckland Champ of Champs titles
- Howick Hawks win 1-5 Year Mercedes Cup, it's the first time an Auckland team has won the trophy since 2017-2018
- Matariki was celebrated as a public holiday for the first time, enabling Te Atatu Peninsula, Glen Eden, and Epsom to establish and host new events.
- Auckland Men's Open Prem rep side won the Regional Intercentre event and will represent Auckland at the National Finals in October
- Leif Selby and James Williams from Carlton Cornwall Bowls win back-to-back National Men's Champ of Champs Pairs titles
- Tony Grantham achieved silver for 2022 National Open Singles and 2022 Open Pairs

# SUPPORTING OUR CLUBS

Assisting clubs to become more operationally efficient is an ongoing goal for Auckland Bowls. During lockdown our support was via online technology rather than face-to-face social interaction, but we continued to:

- work with Clubs to keep them up to date with Covid "dos and don'ts"
- provide Clubs with tips on minimising costs during closure
- encourage and assist Clubs with applications for the range of subsidies and grants available
- maintain regular contact with Club executives

# **OUR EVENTS**

As lawn bowls is primarily played outdoors, we were fortunate to successfully play most of our Centre programme – only having to side-line or reschedule a few events.

1-5 Year players are a very active group and they continued to make meaningful contributions within their division as well as in senior club teams. The numbers participating in competitions is a promising sign for the future of bowls.

Live streaming events across our bowling communities (both here and overseas) has really grown and certainly enhances the opportunity to watch and support bowling events. We will continue to provide great online coverage with live streaming of key events.

# HIGH PERFORMANCE

Taking a big picture view, we have initiated the delivery of a new highperformance representative structure. A recent review identified we needed to make some fundamental changes to this activity. We worked through our past performances, consulted with bowlers for feedback and researched how other sporting bodies operate their representative teams.

It became clear that Auckland Bowls needs to become more progressive if we want to improve and achieve our goal of being the top performing Centre in New Zealand. Everyone understands that a high-performance team needs to work as a cohesive unit to succeed – therefore we will be focussing on the following:

- develop more collaboration, coordination, and cohesion across the entire squad
- have a positive team with a sense of pride and ownership developing and building a great team culture will enable success, which in turn, will attract more talent
- introduce a transparent and structured approach to our player selections
- introduce a selection process with clear and concise criteria identify key components and apply some subjective elements to recognise diverse, passionate, and committed team members

Our high-performance activities will include specific coaching, skill-set training, and player development programmes. Player performance can then be measured and monitored, the results analysed and used as part of the player selection process.

As part of our ongoing support, we are committed to encouraging and enabling talented bowlers to compete in key marquee events throughout New Zealand. We have already started to identify relevant bowlers and offer some assistance with entry and travel costs.

# COACHING AND PLAYER DEVELOPMENT

One of the most exciting initiatives Auckland Bowls has undertaken, is the appointment of former bowls world champion Leif Selby to the position of Coaching and Player Development Manager. Since taking up his role in November 2021, Leif has already made his mark:

- conducting Skills Coaching clinics at Clubs
- delivered Foundation Coaching course, in conjunction with Bowls NZ, to 15 club bowlers in our region
- implemented Skills Training Academy for promising players
- developing and progressing a Secondary Schools Programme in association with Clubs

These activities will lead to positive outcomes for Clubs and players.

# FINANCIAL PERFORMANCE

It was pleasing that as we dealt with a challenging year, our financial result recorded a net profit of \$53,700. We were able to achieve savings across several areas, as well as receiving government subsidies to enable our team to continue to work effectively to support our Clubs.

Our balance sheet remains strong with total assets of \$10.7 million and funds of \$3.6 million, while the Kimberley Investment Fund continues to achieve good net returns. These resources will provide a great platform for the growth and development of the sport of bowls for many years.

# **Entity's Purpose:**

Auckland Bowls is the regional governing body for lawn bowls and is committed to delivering a sport that is enjoyable, entertaining and accessible to the people of Auckland and visitors to our region. We are committed to more people playing and enjoying bowls more often.

# **Entity's Mission:**

Lead and grow the sport of Bowls in Auckland

# **Entity's Structure:**

Auckland Bowls is governed by a seven person Board, with the President and Vice President elected by the members; and five independent Board Members recommended to the AGM for appointment by the Selection Panel in accordance with the Constitution. Auckland Bowls currently has four full-time and one part-time staff, based at the Mt Eden office.

# Main Source of Income:

Income is generated in the main through membership fees, grants, sponsorship, contracts and event based activity.

# Entity's Reliance on Volunteers and Donated Goods or Services:

Like many not-for-profit organisations, Auckland Bowls is dependent on volunteers who assist with all facets of delivering the sport to the members and participants. Without these volunteers the organisation could not function.

# **Description of the Entity's Outcomes:**

Auckland Bowls is responsible for the administration, promotion and development of the game of bowls within its defined boundaries. This includes providing support services for its affiliated clubs; events and tournaments for members and visiting participants; and to promote and grow the sport.

# Description and Quantification of the Entity's Outputs:

Auckland Bowls has a combined membership and participation base of 18,987 (2021: 30,108). The total number of entries in Auckland Bowls run events was 711 (2021: 1,267), for a total of 2,479 participants. (2021: 3,693). Due to COVID-19 restrictions there were several events that were cancelled.

# Additional Information:

Auckland Bowls was first established in 1896 and has 40 affiliated clubs (2021: 40). It covers the area from the Auckland Harbour Bridge in the north to Papatoetoe in the south; from Piha in the west to Maraetai in the east.

# 1. STATEMENT OF ACCOUNTING POLICIES GENERAL ACCOUNTING POLICIES

The measurement base adopted is that of historical cost. Reliance is placed on the fact that the business is a going concern. Auckland Bowls Incorporated has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses of equal to or less than \$2,000,000. All transactions in the Financial Reports are reported using the accrual basis of accounting. The Financial Reports are prepared under the assumption that the entity will continue to operate in the foreseeable future.

# **Specific Accounting Policies**

The following specific accounting policies which materially affect the measurement of financial performance and financial position have been applied.

### (a) Valuation of Assets

Fixed Assets have been recorded at cost less accumulated depreciation. Listed investments have been recorded at market value (refer notes 5 and 6). Movements in market value of listed investments are reflected in the Investment Revaluation Reserve. Other investments are valued at cost plus accrued interest.

Accounts Receivable have been recorded at estimated realisable value. Where a debt has been considered irrecoverable, it has been written off in the Statement of Financial Performance.

### (b) Depreciation of Fixed Assets

Fixed Assets have been depreciated on a straight line basis over the expected life of the asset with the exception of Leasehold Improvements which are being depreciated over the anticipated term of the tenancy lease.

### (c) Goods and Services Tax

All amounts are recorded exclusive of GST, except for Debtors and Creditors which are stated inclusive of GST.

### (d) Tax

Auckland Bowls is an Incorporated Society and an amateur sports body and has been granted exemption from income tax by Inland Revenue under Section CB 4 (1) (h) of the Income Tax Act 1994.

### (e) Leases

Operating lease payments, where the lessors effectively retain substantially all of the risks and benefits of ownership, are included in the determination of the net surplus in equal instalments over the lease term.

### (f) Changes in Accounting Policies

There have been no changes in accounting policies during the financial year.

### 5. RAWHITI PROCEEDS

At an SGM of the Rawhiti Bowling Club (RBC) on 28th September 2014 the members resolved to transfer certain assets (\$5,413,867.92) to Auckland Bowls Incorporated to establish a Fund to be known as the Rawhiti Fund. The Rawhiti Fund is administered by Auckland Bowls in accordance with the Deed of Agreement made between RBC and Auckland Bowls dated 11th May 2015.

At the same SGM a separate sum of \$1,109,997 was set aside for specific grants to be given to Clubs where members of RBC had joined. Auckland Bowls managed these funds on behalf of RBC. Auckland Bowls received an initial fee of \$7,000, plus the ongoing interest whilst the funds remained under Auckland Bowls management. Following distributions to approved Clubs the fund balance is \$0.

# RAWHITI FUND COMMITTEE REPORT

The Rawhiti Fund provides practical financial support to Clubs in our region to carry out facility enhancements and growth opportunities. The Rawhiti Fund continues to be held in term deposits as outlined in the Deed of Agreement, with the risk spread across three banks. It provides a low-risk income for the Fund and will continue to be invested and spent on Club development, covered greens, marketing of the sport of Bowls and a Facility Enhancement Fund.

Several Clubs have utilised CDA's, all having great success in promoting the game of bowls, increasing participation and generating new members.

This financial year, a total of \$333,000 was granted for CDA's, distributed across 11 Clubs. In addition, two more clubs have received Facility Enhancement grants with a total value of \$62,000. There was also a contribution towards the construction of the covered green at Papatoetoe Hunters Corner of \$295,000. The Rawhiti Committee has also approved further funds of \$1,184,000 for covered greens, facility enhancements and CDA's, which will be actioned during 2022-2023.

Auckland Bowls would like to thank and acknowledge current Committee members; Graeme Bennett (Chairman), Ian Dee, Michael Feek, Gerard Hulst, and Allan Smith for their contribution during the financial year.

We look forward to providing ongoing support to our club network.
