CHAIRMAN'S REPORT

Auckland Bowls purpose is to lead and grow the sport of bowls in Auckland. We all want to see more people enjoying the game of bowls. Some of the major issues facing Auckland Bowls in 2018/19 were: -

General Manager

The role of the General Manager of Auckland Bowls is a key one in establishing the reputation, image and performance of Auckland Bowls. Our longstanding General Manager, Phil Vyver, announced his resignation as from 17 May 2019. He has decided that after ten years in the post the time is right for someone to take up the challenge. Phil has devoted himself to promoting bowls in Auckland over a long period. We are going to miss his considerable experience and knowledge and we wish him well for the future.

Prior to going to press the Board appointed Steven Yates as our new General Manager.

Club Development

Bowls as a sport can only thrive if we have an active network of sustainable and forward-looking clubs. Fortunately for clubs in Auckland we have funds, made available by the Rawhiti Club, to form a partnership programme with Auckland Bowls to support clubs who wish to advance, develop, promote and grow the game of bowls. Over the past two years, 17 clubs have entered into the Club Development Agreements with Auckland Bowls, with funds of \$205,000 being granted in 2017/18 and \$361,000 in 2018/19. We are also supporting the establishment of five or six covered greens around the city. The New Lynn Club covered green is up and running, Remuera has commenced construction and two are in early planning stages.

We have just reviewed the effectiveness of what we have been doing over the first two years of our club development programme to see whether our plan is working well or whether it can be improved. Some of the things that have been working well include:

a) There has been explicit conversation with many clubs about how they could be more effective and find different ways to attract new members and increase casual participation at their clubs. These discussions are slowly opening a fresh perspective on what can be possible. Within the Auckland Centre in the last 12 months, twenty of our forty clubs have increased their membership (something previously thought to be unlikely) and the number of casual participants has increased from 27,300 to 32,000. The Board is pleased to see signs of growth and revival in half our clubs. This should motivate us all to continue to build on the success being achieved.

b) Staff employed under the scheme have enabled a range of extra activities to be undertaken that clubs couldn't resource with their own funds. This includes, for example, help with running casual events, assistance with hosting corporate functions at clubs, improved club marketing, extra involvement with schools and improved coaching.

Some of the things that have not worked well include:

a) The concept of grouping clubs and having cooperation between clubs has not worked because of clubs valuing "independence" above working together for the greater good.

b) With many clubs not having development plans of their own, it has been hard for the staff employed to have clear direction on what they are meant to be doing and what results the club wants. c) When Auckland Bowls has tried to assist in helping define what results a club may want there has been some friction and communication issues.

As a result of our review we have decided to alter our approach so that we can build on the successes and try to eliminate some problem areas. Key features of our revised approach are:

a) We do not have an unlimited pool of funds. We will therefore give initial priority to supporting clubs that want to develop and grow, rather than those just trying to survive until they run out of money or run out of volunteers.

b) We will call for initial applications for the next round of funding from the 17 clubs that have already taken up the opportunity to have Club Development Agreements along with 10 more clubs that have shown a record for attracting significant numbers of casual participants. The emphasis will be to ask these clubs for their own ideas and commitments that are appropriate for their particular situation.

c) We hope to approve a series of grants in September to help these clubs to continue increasing the number of members and participants enjoying the sport.

Affiliated Clubs Policy

In light of a number of events over the last year it is timely to remind member clubs of a provision in Auckland Bowls Affiliated Clubs Policy. This policy requires clubs, before reaching a decision involving a change to land ownership, major facility redevelopment, amalgamation or winding up, to discuss the proposed change with Auckland Bowls at the earliest possible time and before any meeting is held to make a decision. One of the purposes of this policy is to enable Auckland Bowls to help clubs get the best advice or assistance they may need or suggest superior options that haven't been considered. Unfortunately there have been a number of recent cases where clubs have got out of their depth and have lost, or might lose, their club along with their considerable assets. Avondale Club is a well-known example but there is another club that is in bad shape and another in a risky situation. Auckland Bowls has had to spend time and resources trying to help resolve and sort out problems that should never have occurred in the first place if our policy was adhered to.

Board and Staff

Esther Eu was co-opted to fill a Board vacancy during the year. Her skills in finance, coaching and asking curly questions as a means of solving problems allows her to make a valuable contribution.

Your Board is a diverse but united group with everyone working well together. My sincere thanks to each Board member for their insights and contributions.

We have a small staff team of Steve Clifton (also acting as General Manager during the vacancy), Kristina Fry, Paul Tuckley and Janine Young. We appreciate their continuing important contributions. *Continued Page 4*

Contributors to the Sport

This is an appropriate time to recognise that Auckland Bowls is well placed financially as a result of actions taken by visionaries in the past and carried on by current members of the Rawhiti Committee, Kimberley Committee and the Blue Waters Community Trust. The Blue Waters Community Trust chaired by Chris Day has contributed \$447,177 to various aspects of our work this year. The Rawhiti committee chaired by Graeme Bennett has contributed \$445,966 to support club development and the Kimberley Fund chaired by Bob Croker has increased the value of its investments by \$649,438 during the year. PRESIDENT'S REPORT

This is my second year as President of Auckland Bowls, and I have much pleasure in presenting the following report for the 2018-2019 season.

Auckland bowlers have enjoyed a year of good weather, good greens, the hosting of the National Singles and Pairs and some excellent overall competition results. We have seen the closing of some Clubs and the revival of others. Playing numbers have once again decreased but it is pleasing to note that participation in our game has increased by 17.3% to over 32.000. We have also had an increase of 75% in first year bowlers. Now it is the Clubs' responsibility to turn some of these participants into bowlers and to retain the 231 first year bowlers recruited. Apart from natural attrition, we have seen the exodus of players from Auckland to Retirement Villages in other locations i.e. Tauranga and Kerikeri.

New Lynn has used their covered stadium to the full, hosting their own tournaments and Auckland events. The highlight of their season was the Televised Bowls3Five which was great publicity for New Lynn and the game of bowls. Many Clubs reported an increase in bowls participation after this event. Remuera will have their covered green ready for the new season. With two or three other covered amenities muted we will have competitive bowls all year round in our city. This opens the ideas for new formats, and fast and exciting games for those who have little time to spare for recreation.

The Auckland Representative teams have been a credit to Auckland Bowls. Under excellent Management and Coaches, and a smart uniform, they competed well. Team spirit was high and the results reflected the effort put in by those selected. The season culminated with the Ladies Open Team winning the National Inter Centre at Howick. This trophy was last in Auckland 21 years ago.

The National Pairs and Singles went well for Auckland players with our Men taking out the Singles and Pairs Titles. Auckland members also were part of the Ladies Pairs title and runner up in the Ladies singles. Thank you to the hosts Carlton Cornwall and their volunteers who did an amazing job. Live streaming came to the fore at this organisations in their own way have achieved excellent results in the last year and we appreciate their efforts on behalf of the bowlers in Auckland.

We are also grateful to the large number of volunteers, including the Umpires Association, involved in running our Events Programme and our High Performance Programme. Thanks also to Graeme Clisby who chairs our Finance Committee and Gerard Hulst who Chairs the Operations Committee.

During the year a wide range of club members have assisted with help and advice without which Auckland Bowls could not function effectively. Our thanks to you all.

The Club Development Plan which was put in place last year has proved to be a challenge for some Clubs. Many do not having the resources to reach their targets. We have had some valuable assistance from Club Managers and Club

Development Officers but there has been a lack of good volunteers and those to assist with the running of the Clubs. Auckland Bowls has provided resources in the form of advertising and funding from the Rawhiti Trust and we hope to see returns more favourable for Clubs in the coming season.

Once again I would like to thank all Coaches, Umpires and Convenors who brave all kinds of weather to help coach our juniors and officiate at all of our tournaments. Your members are dwindling as well and we hope to have some innovative ideas this year to boost your numbers. To the Canoe and Campi Cup coaches – keep up your good work. With 231 first year bowlers you have a sound basis for your winter coaching. I encourage Clubs to promote this coaching to help retain these players. They are the future of your Club. Our volunteers are the heart of our Club. Please continue to look after them.

Our Board has worked hard for you this year. Behind the scenes there have been many hours spent trying to achieve success in all the decisions we make. I would like to thank the Auckland Bowls Board, the Auckland Bowls Staff, the Rawhiti Committee, The Finance Committee, the Operations Committee and our Legal Advisor, for all their work in achieving a successfully run business. Our Board Chairman, Bruce Anderson, has worked tirelessly for Auckland Bowls and I thank him for his great contribution.

Finally I would like to thank Phil Vyver for his work at Auckland Bowls. After 14 years, Phil is moving on. We wish him well in the future.

GENERAL MANAGER'S REPORT

As this is my final report as General Manager, I would like to begin by thanking all the bowlers for their support over the past 14 years. It has been a pleasure to lead Auckland Bowls and to work with so many dedicated people at centre and club level. The passion you have for the sport is incredible.

It has been a great privilege being General Manager of Auckland Bowls. Whilst there have been and remain some significant challenges, I am proud of what has been achieved by a great team of staff and volunteers. The introduction and growth of the New Zealand Open was a highlight as was seeing the continued growth in both the profile and participation numbers in the sport. The financial contribution from the Rawhiti Bowling Club and the subsequent Successful and Sustainable Club Network Plan has and will continue to be a great boost for the sport. The push to see more covered greens in Auckland has also been a positive step. With Remuera underway and a number of others planned, Auckland will have top class facilities available for all members and participants.

Auckland Bowls is in a great position with a strong financial base and the highest participation numbers ever recorded. The transition of these people from participants to members or at least more regular participants remains the ongoing challenge. If this can be achieved, then the sport will have a very positive future. If just 1 - 2% of casual participants became full playing members each year we would have a growing membership base.

I encourage clubs to get in behind Auckland Bowls and to take advantage of the funding and support that is available. By working together, you will be able to achieve all you want for your club.




Finance

An operating profit for the year of \$11,651 has been recorded. When the cost of depreciation and income from the Kimberley Investment Fund is added, an overall surplus of \$127,657 has been achieved.

We often get asked what does Auckland Bowls provide for bowlers? All revenue contributes to the following key benefits that are available to all members and clubs:



- Club Development Agreements and funding for Club Development Staff
- Marketing; Advertising and Promotions; Communication.
- Events and competitions for existing players and new participants
- High Performance and Youth Bowls

In line with the Strategic Plan expenditure has increased significantly for Club Development and Support, now representing 52% of overall expenditure (\$487,525). This investment has contributed to the increased profile of the sport and the associated growth in casual participation.

Events and Tournaments is the next largest area of expenditure with \$224,384 being spent, down slightly on 2017 (\$236,067). Together these two areas make up 76% of total expenditure.

It is worth noting that Membership Fees make up just 4.8% of total income. The remaining 95.2% of income that pays for the above benefits is generated through areas such as grants, sponsorship, interest and entry fees.

The Balance Sheet remains very strong. The funds held and managed by the Kimberley Investment Committee (see separate report) continue to grow at a steady rate, with an impressive 13% return for the year. Financially Auckland Bowls is in the best position it has ever been in with assets of over \$11m and equity of \$6m with substantial funds available for investment in the growth and development of the sport.

Events and Operations Committee



On the green it has been in a stellar year with some stand out performances by both men and women. This is highlighted by the Auckland Women's Side winning the National Intercentre Title. This is a brilliant achievement led by coach Diane Harris. Congratulations to all involved. At the National Open Championships expertly hosted by Carlton Cornwall Bowls, we saw Jordan King and Chris Lowe (Mangere) win the Men's Pairs and Taylor Horn (also Mangere) the Men's Singles. An outstanding achievement! Thank you to Carlton Cornwall Bowls and all the other host clubs for doing a great job in hosting this tournament. events this season and for your support and expertise whenever required.

The events programme and the way tournaments are run divides opinion like nothing else. It is extremely hard to get a consensus of opinion when it comes to events. Survey results are always split, which means we are always right or always wrong depending on who you talk to! Either way this is a challenging area and I thank all the staff and volunteers involved in running the events.

Thank you to every umpire that has officiated over the past year. Whether it be once or many times your support is greatly appreciated! Put simply we could not run our events without you. More umpires are required however, and I know this is an area that the Umpires Association has been working on. If you would like to be an umpire or measurer then put your hand up and get involved.

The greenkeepers also do an outstanding job in often difficult conditions given the variable weather in Auckland and the many opinions of bowlers! Thank you for your efforts this season.

Auckland Bowls is supported by an excellent group of sponsors and funders. Most notably the Blue Waters Community Trust who remain a significant contributor to Auckland Bowls and several clubs in Auckland and we thank the Trustees for their ongoing commitment to bowls in Auckland. Thank you to Ryman Healthcare who continue as our primary corporate sponsor. This has proved to be a mutually beneficial arrangement with

many bowlers now calling a Ryman Village home.

I have worked with some excellent people at both Board and staff level over the years and I thank you for your guidance and support. In particular, to the Chairs I have worked with Terry O'Connor, Hadden Vernon and Bruce Anderson. Your support of me and commitment to bowls in Auckland is appreciated.

Entity's Purpose:

Auckland Bowls is the regional governing body for lawn bowls and is committed to delivering a sport that is enjoyable, entertaining and accessible to the people of Auckland and visitors to our region. We are committed to more people playing and enjoying Bowls more often.

Entity's Mission:

Lead and grow the sport of Bowls in Auckland

Entity's Structure:

Auckland Bowls is governed by a seven person Board, with the President and Vice President elected by the members; and five independent Board Members recommended to the AGM for appointment by the Selection Panel in accordance with the Constitution. Auckland Bowls currently has three fulltime and two part-time staff, based at the Mt Eden office. An additional five part time staff are based at bowling clubs.

Main Source of Income:

Income is generated in the main through membership fees, grants, sponsorship, contracts and event based activity.

Entity's Reliance on Volunteers and Donated Goods or Services:

Like many not-for-profit organisations, Auckland Bowls is dependent on volunteers who assist with all facets of delivering the sport to the members and participants. Without these volunteers the organisation could not function.

Description of the Entity's Outcomes:

Auckland Bowls is responsible for the administration, promotion and development of the Game of Bowls within its defined boundaries. This includes providing support services for its affiliated clubs; events and tournaments for members and visiting participants; and to promote and grow the sport.

Description and Quantification of the Entity's Outputs:

Auckland Bowls has a combined membership and participation base of 34,487 (2018: 30,353). The total number of entries in Auckland Bowls run events was 1,204 (2018: 2,113), for a total of 3,489 participants (2018: 5,297).

Additional Information

Auckland Bowls was first established in 1896 and has 41 affiliated clubs (2018: 42). It covers the area from the Auckland Harbour Bridge in the north to Papatoetoe in the south; from Piha in the west to Maraetai in the east.

1. STATEMENT OF ACCOUNTING POLICIES

GENERAL ACCOUNTING POLICIES

The measurement base adopted is that of historical cost. Reliance is placed on the fact that the business is a going concern.

Auckland Bowls Incorporated has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses of equal to or less than \$2,000,000. All transactions in the Financial Reports are reported using the accrual basis of accounting. The Financial Reports are prepared under the assumption that the entity will continue to operate in the foreseeable future.

Specific Accounting Policies

The following specific accounting policies which materially affect the measurement of financial performance and financial position have been applied.

(a) Valuation of Assets

Fixed Assets have been recorded at cost less accumulated depreciation.

Listed investments have been recorded at market value (refer notes 5 and 6). Movements in market value of listed investments are reflected in the Investment Revaluation Reserve. Other investments are valued at cost plus accrued interest.

Accounts Receivable have been recorded at estimated realisable value. Where a debt has been considered irrecoverable, it has been written off in the Statement of Financial Performance.

(b) Depreciation of Fixed Assets

Fixed Assets have been depreciated on a diminishing value basis over the expected life of the asset with the exception of Leasehold Improvements which are being depreciated over the anticipated term of the tenancy lease.

(c) Goods and Services Tax

6. RAWHITI PROCEEDS

At an SGM of the Rawhiti Bowling Club (RBC) on 28th September 2014 the members resolved to transfer certain assets (\$5,413,867.92) to Auckland Bowls Incorporated to establish a Fund to be known as the Rawhiti Fund. The Rawhiti Fund is administered by Auckland Bowls in accordance with the Deed of Agreement made between RBC and Auckland Bowls dated 11th May 2015.

At the same SGM a separate sum of \$1,109,997 was set aside for specific grants to be given to clubs where members of RBC had joined. Auckland Bowls managed these funds on behalf of RBC. Auckland Bowls received an initial fee of \$7,000, plus the ongoing interest whilst the funds remained under Auckland Bowls management. KIMBERLEY INVESTMENT COMMITTEE REPORT


In 2006 Auckland Bowls received \$2,065,000 from the sale of its Kimberley Road property. The Kimberley Investment Committee was then set up and consists of Bob Croker, David Timms, Murray Lander and Gavin Brown. Members are appointed by the Auckland Bowls Board for a two-year term, with a rotation policy in place where two people are eligible for reappointment each year.

Long standing members Graeme Bennett and Hadden Vernon stood down at the end of the previous financial year. I would like to take this opportunity to thank both gentlemen for their valued contribution to the committee since its inception.

The funds have a current market value as at 30 April 2019 of \$5,747,424. This represents an increase of 12.77% on last year (\$5,096,573). In accordance with the Statement of Investment Policies the portfolio has been diversified and now includes:

RAWHITI FUND COMMITTEE REPORT

Following the sale of the Rawhiti Bowling Club a Deed of Agreement was signed by Auckland Bowls and the Rawhiti Bowling Club. As part of the Deed a Rawhiti Fund Sub-Committee was set up comprising two members appointed by the Rawhiti Bowling Club, and three members appointed by the Appointments Panel.

The current members of the Rawhiti Fund Sub-Committee are Graeme Bennett (Chairman); Bruce Anderson; Michael Feek; and Rawhiti Bowling Club appointments Rod College and Gerard Hulst.

As at the 30th April 2019 the fund is \$\$5,315,695 (2018: \$5,574,707) after allowing for income and expenditure.

In line with the Deed the funds are being used to develop the sport in Auckland. A total of \$445,966 was distributed during the year. The funds have been spent in three main categories. Firstly, for the continuation of the Club Development Programme with 17 clubs benefitting from funding. This is up from the initial five clubs that were funded the previous year. A total of \$239,966 was paid out to clubs to assist them with the promotion and development of the game at the local level.

A review of this Club Development programme has been completed and an improved application process is now being introduced. Twenty-seven clubs have been asked to complete the new application form. Funding will cover the next two seasons.

Secondly, funds were spent on the start of the Covered Green Project. Remuera Bowling Club is the first to benefit in this regard with their new covered facility now underway and due for completion shortly. Other clubs will also benefit from this fund with the aim of a further three covered facilities in Auckland. These funds will greatly contribute to Auckland having a world class network of bowls facilities. Thirdly the funds were used for the marketing and promotion of the game at Auckland Bowls level. This included the introduction of a Membership Management System which is now being rolled out and is available for all clubs. If your club has not yet taken advantage of this programme, then please do so.

The funds are held in term deposits as outlined in the Deed of Agreement with the risk spread across three banks. This provides a low risk income for the fund, that in time will be spent on club development projects.

Thank you to my fellow committee members for their commitment and I look forward to working with you again in 2019-2020.


