Why is the Kimberley/Rawhiti money not used to help clubs in financial distress?

#### Answer: Bruce Anderson – Chairman

Auckland Bowls is at present reliant upon Blue Waters Community Trust for funding operating costs. This funding is not assured for the future. BA called upon Allan Smith, BWCT trustee for further comment. Allan Smith reiterated, that future funding was not assured, with BWCT going from five venues down to one.

Bruce Anderson advised, the constitution states that the Kimberley Fund is a major capital asset of Auckland Bowls and should be kept intact as far as possible in order to meet the future needs of Auckland Bowls and its members. This comment was supported by Graeme Bennett former member of the Kimberley Committee. The Rawhiti Fund was established at the closure of Rawhiti Bowling Club to be used for future investment in the growth of the sport. Ian Birch was happy with this explanation and thanked Bruce Anderson for his response.
