Following all input Bowls NZ will release the 2020/2021 Playing Program. The only Bowls NZ events to be played this calendar year is the Bowls3Five Play-offs and the Bowls3Five TV League. The nationals and Intercentre Tournaments will be played at the same time as scheduled for this season. ABI provided feedback about inclusion of Women's Premier Singles in Summer of Bowls Calendar. Once Playing Program is confirmed SY will distribute to ABI Staff and Operations Committee.

#### **General Business:**

Government COVID-19 Wage Subsidy – Board praised SY for early application and approval of Wage Subsidy for ABI staff.

Intention of applicant was compliant with Government Requirements at time of application.

Board want total comfort that projected Revenue/Income meets the 30% reduction threshold when comparing May/June 2019 with same period in 2020. SY to provide calculations and seek advice from Work and Income.
