#### 5 General Business:

#### 5.1 Affiliation Fees

MF gave the background on his research on Affiliation Fees for playing members, noting the range across the country. MF also explored and gave an update to the Board on the average salary and wages or honoraria payments across the country.

Discussion was held and it was agreed in the current climate there would be no increase in Affiliation Fees, and it would be revisited in 2022.

Further discussion was held on work that needed to be done to look at future funding for Auckland Bowls. The Chair and MF would meet to look at drafting a proposal.

It was confirmed the fees were approved at the AGM in July 2021 and invoices would be circulated to clubs this week, based on updated Bowls NZ membership as at 31 December 2020.

The Chair recognised and thanked the great work MF had undertaken and reiterated that investigating future funding was imperative.

#### 5.2 Vaccination Guidelines

The GM gave an update on his conversation with the CEO from Bowls NZ and their recommendations and guidelines. This is in the final stages and the GM expected to receive the paper shortly.

#### **Key points:**

- Discussion across clubs about mandated vaccinations and how they go about it.
- From Bowls NZ perspective tournaments will only take place at venues and clubs that have a vaccination policy. Players will only be able to enter if they have been double vaccinated.

- Currently operating under level 3 phase 1 until the government have further updates on the traffic light system process.
- Vaccinated certificates won't be available to use until at least mid-December, although the government indicated today it may be as early as end of November.
- The GM noted it would be difficult for clubs to monitor and request medical information. The key is how to manage at the club level.

HB expressed that the Board's role and responsibility was to communicate and encourage people to get vaccinated. It was noted that the first event is 11 December 2021 and the government announcement on 29 November would drive next steps. HB highlighted that Conditions of play would be when the Board should have another discussion around mandating vaccinations.

The GM confirmed he would circulate the Bowls NZ recommendations and guidelines paper to the Board once he received it.

It was highlighted by the GM that Club revenue was dependent on not only corporate and business house bowls events but also on other community groups utilising their facilities. The clubs would need a clear guideline moving forward. It was also noted that it was up to the individual clubs to make the decision on their approach to this issue.

- 5.3 1-5 year's men's - update was given by JR, with little progress made due to Covid restrictions.
- 5.4 Open Woman's - update given by HB, noting they had managed to come together and get in some practice.

It was confirmed that the 1-5 year's criteria to be on the Operations Committee Agenda for further discussion.

#### 5.5 Remuera Bowls subcommittee

JR gave an update on the Remuera Bowls subcommittee, noting ID, HB and the President of Remuera Club were on the subcommittee. Mr Graeme Bennett was involved in an advisory role.

Mr Ross advised two meetings had been held with some progress made.
