## CONDITIONS OF PLAY

1. Status:

Conditions of Play are written per Law 55.3* which permits Bowls Auckland as the Controlling Body to establish conditions of play to cover certain aspects of the event.
2. Controlling body:

The Controlling Body for this tournament is Bowls Auckland.
The Controlling Body will have the right to alter, add to or delete any conditions of play at any time to enable the completion of the event.
3. Composition of sides:

Each Side will include 16 players, 8 men and 8 women, with the option of reserves
Counties Manukau will provide one side, Bowls Auckland will provide two
Each Side's will play $2 x$ pairs and $2 x$ four matches
Substitution during a game is not permitted, except for illness or injury.
Each player can only play a maximum of 2 games in each discipline.
4. Cell phones (electronic devices), smoking \& alcohol policy
a. Use of personal electronic devices is not permitted by Players on or alongside the greens during play. It is preferred that cell phones be switched off or turned to silent.
b. Cigarettes, e-cigarettes, and vaping are not permitted in the clubhouse, on the green or in the immediate surroundings.
c. Host clubs will have designated 'smoking area/s' for Players, officials, and spectators.
d. The drinking of alcohol is to be confined to the designated areas, in line with respective host clubs' licensing agreements and host responsibility policy.
e. Alcohol is not permitted on greens.
5. Advice by coach:

The Coach, or their appointed substitute, can advise a player on their side during the competition, in line with the Laws of the Sport of Bowls.

The names of the Team Manager(s) and Team Coach(es) must be handed to the Tournament Convenor before the commencement of play.
6. The draw:

The draw (as above) is predetermined, each side will face in fours and pairs contests over 4 rounds.
7. Format:

Pairs 3 bowls each 16 ends or 1 hr 55 min - whichever comes first
Fours 2 bowls each 12 ends or 1 hr 55 min - whichever comes first
8. Time limit:

All games are to be continued irrespective of the score until the designated time limit is over or until the total number of ends have been played, whichever comes first.
If the Jack has been delivered before the time signal, the end will continue.
9. Dead Jack:

If at any time the end is dead, the end will be replayed. (Including after the time limit*)
*For any end where the jack has been delivered after the time limit, the end shall not be dead, and the jack re-spotted on the 2 m mark.
10. Trial ends:

Before the start of the first game, each player will be allowed two trial ends.
A rink will be made available by the tournament director for substitute players to have free practice.
11. Restricting the movement of players:

In all games, the movement of players during play shall be restricted according to Appendix A. 4 of the law book.
12. Determining a winner:

In all games three (3) points will be awarded for each game won and one (1) point for each game
drawn. The points will be cumulative among the Men's and Women's sides.
The winning side will be determined by the highest game points.
If game points are equal, the winner will be the side with the highest net total of shots.
If the game points and the net total of shots are equal, the side with the lowest "total shots against" will be the winner.
13. Variations to conditions of play:

In the event of inclement weather, or any other extraordinary circumstances, the Controlling Body may vary the Conditions of Play by reducing the number of ends and/or time limit of any game; or reducing the number of games. Any decision made must be before the commencement of a game.
14. Inclement weather: If play is stopped due to weather conditions, the following shall constitute a game:
Pairs 9 ends
Fours 7 ends
A short bell will signal the current end is to be finished and the play suspended A long continuous bell will signal play to stop immediately, any end in play will be dead.
