What a sport we have—where a 20-year-old and a 70-year-old can compete at the same level, as we saw with the winners of the recent Champ of Champs Mixed Pairs. What an opportunity we all share to shape the future of bowls.



As we look to the future, our focus sharpens on innovation, and building enduring club and community connections. With strong foundations in place, Bowls Auckland is advancing with purpose to ensure we are future ready.

Over the past year, we have continued to evolve our Strategic Plan, progress delivery, and grow the game through the strengthening of our club network, bringing to life our strategic intent: supporting clubs to be the heart of their community. With a stable foundation now laid, we move to the next stage making our strategy more innovative and forward thinking. We will focus on the next evolution of our support for clubs and, in turn, the growth of the game.

Recent census figures are revealing and highlight the changing face of bowls participation and club engagement. Encouragingly, we are seeing significant increases in less traditional formats, such as social memberships and casual play (i.e. corporate events). It is clear that as our game and our clubs evolve, so too must the support we offer at the centre level to maximise these opportunities and set our sport up to thrive in an exciting future.

Fortunately, several clubs have already embraced this change, and our collaborative focus must now be on engaging with the wider community — bringing more people into our clubs to experience the range of activities available, both on and off the green. We aim to support clubs in converting casual or corporate engagement into modern membership categories, embedding clubs even deeper into their neighbourhoods as genuine community hubs that attract not only members, but also their families and friends.

At Board level, we continue to enhance our governance and best-practice capability to remain fit for purpose. We maintain strong attention to our Board Annual Work Plan, Risk Register, and Board Skills Matrix. The Board possesses a broad range of skills and works cohesively for the betterment of Bowls Auckland, offering strong support to the management team. It is pleasing to report another successful financial year in which, through prudent management, we achieved a surplus and grew our balance sheet.

We are approaching a time of significant change to our funding model. Thanks to the foresight of those before us, we are well-positioned to absorb these changes and to sustainably bridge any potential gaps in funding.

The Blue Waters Community Trust will cease operations due to the gaming licence being unable to be transferred to another venue. This brings to a close a 25-year-plus legacy of investment that deserves celebration. Importantly, it has allowed the Kimberley Trust Investment Fund to grow mostly untouched, enabling future investment in both Bowls Auckland and its clubs.

Similarly, the Rawhiti Fund is set to wind down in 2025, as per its Deed, after 10 years of investment in clubs. Bowls Auckland acknowledges and sincerely thanks all involved in both the Blue Waters and Rawhiti entities, including the Trustees and Committee Members, for their dedication and service.

We are acutely aware of the importance of maintaining direct funding into clubs and are planning to launch two new initiatives to meet this need. These are the Bowls Auckland Development Foundation Trust and a new club investment fund, which will be announced following the closure of the Rawhiti Fund later in 2025.

As many clubs have done, we too are in the process of drafting a new constitution to align with re-registration requirements under the Incorporated Societies Act 2022 and will complement the broader changes and initiatives outlined above.

To help clubs thrive, Bowls Auckland continues to focus on building its long-term capability— both organisationally and financially. Across Tāmaki Makaurau clubs have grown stronger thanks to the incredible mahi of their volunteers and support personnel. Thank you for continuing to make bowls a community for all and a game for life.

STRATEGY AND VALUES -EMBEDDING INNOVATION

We've entered a new era of growth and momentum. With membership decline reversing, Bowls Auckland has evolved its strategy to lead confidently into the future. A key milestone was the introduction of a new core value: Innovation — empowering us to think differently, act boldly, and support clubs in more relevant ways.

CAPABILITY - STRENGTHENING FOR WHAT'S NEXT

To help clubs thrive, Bowls Auckland continues to focus on building its longterm capability— both organisationally and financially.

Over the past 12 months we've been developing a Long-Term Financial Strategy to strengthen our future position and create lasting club investment mechanisms. These systems are designed to support club's core needs — from facility development to club management with permanence and purpose. We are excited to unveil these new initiatives in the coming year.

To compliment the introduction of new club investment programmes, we, in collaboration with clubs and Bowls New Zealand have established the Regional Facilities Plan. This provides a framework to identify and prioritise impactful facility projects.

The newly established Playing Programme Committee, involving club representatives and bowlers, has driven improvements with a greater focus on strategic alignment and purpose of centre events. As a result, we've seen a 5% increase in centre event participation — surpassing 4,000 entries for the first time in over a decade. Enhancements to Open Events, Molecheck 7s, and the Auckland Cup all contributed to this lift. Off-green initiatives like the High Tea at the Molecheck Women's Open Singles and Shade Systems Champ of Champs Bowl-a-500 activation, have brought extra energy to the tournament experience.

Through consultation with players and team officials, we launched our Performance Strategy to shape a stronger representative programme. This included the introduction of three Octagonal Tournaments and further development opportunities through clinics run by international player Barrie Lester and Blackjack Head Coach, Mike Kernaghan.

CLUBS - EVOLVING COMMUNITY HUBS

Our clubs are the heartbeat of everything we do, and we are committed to partner with them to create community hubs that thrive in a modern world. This year, we've seen powerful examples of clubs adapting to meet future needs — rethinking membership categories, activating new connections with local communities, and generating alternative revenue streams. These are game-changing developments that deserve recognition.

Financially, we supported clubs through the Avondale and Rawhiti Funds, with over \$2 million awarded or distributed during the 2024-2025 year. This included the newly completed covered green at Papatoetoe and \$227,583 distributed directly from the Avondale Fund in its first year — continuing the legacy of that club in a meaningful way.

To support our club volunteers, we continued the second year of our Club is the Hub programme. Six clubs were supported with management solutions (club managers), and three more received project-based grants. We also launched the Extra End Hero campaign

to celebrate the often-unseen champions in our communities.

Recognising that coaching or providing opportunity for players to develop is essential to increasing participation, we introduced a Coach Development Lead role to deliver our new Coaching Strategy. This focuses on creating coach developers who can inspire and equip both current and future coaches — laying the foundation for the next generation of mentors.

All of this amazing activity and mahi is reflected in our latest census: total membership increased by 15%, and firstyear memberships grew by 9% to 242 the highest on record since 2010.

CONNECTION - REACHING NEW PEOPLE, NEW WAYS With stronger foundations and club

capability, we're better positioned to connect with new audiences in more meaningful ways.

Two growth areas stand out: Rangatahi (Youth) and Twilight Bowls.

Our Rangatahi programme continues to grow, we reached 3,251 students — a 6% increase — and added two new events to the calendar: the Junior Secondary School Pairs and the National Under 26 Pairs. Combined, these led to a 53% increase in youth tournament participation.

Twilight leagues continue to thrive, with over 1,600 players across Tāmaki Makaurau and record participation in the Centre Twilight Finals. Promotional events such as 'Super Bowl II' and in partnership with The Edge radio station, 'Bangers & Bowls' helped drive this momentum. As advances in technology continue, our adoption is reshaping our reach. The full rollout of Bowlshub and Bowls+ has enabled near-instant match updates, player statistics, and more. Meanwhile, our digital footprint has seen significant year-on-year growth: 8,500 followers, and our YouTube livestreams reached over 45,000 views across 10 matches amplifying our game to wider audiences.

LOOKING AHEAD TOGETHER

The future of bowls in Auckland is bright. Together, we're embracing new ideas, new people, and new ways of working — all while staying grounded in the values that define us.

Let's keep building — together.

BOWLS AUCKLAND INCORPORATED FINANCIAL REPORTS

FOR THE YEAR ENDED 30 APRIL 2025

Entity's Purpose:

Bowls Auckland is the regional governing body for lawn bowls and is committed to delivering a sport that is enjoyable, entertaining and accessible to the people of Auckland and visitors to our region. We are committed to more people playing and enjoying Bowls more often.

Entity's Mission:

Lead and grow the sport of Bowls in Auckland.

Entity's Structure:

Bowls Auckland is governed by a seven person Board, with the President and Vice President elected by the members; and five independent Board Members recommended to the AGM for appointment by the Selection Panel in accordance with the Constitution. During the 2025 Financial Year, Bowls Auckland had three full-time and two part-time staff, based at the Mt Eden office.

Main Source of Income:

Income is generated in the main through membership fees, grants, sponsorship, contracts and event based activity.

Entity's Reliance on Volunteers and Donated Goods or Services:

Like many not-for-profit organisations, Bowls Auckland is dependent on volunteers who assist with all facets of delivering the sport to the members and participants. Without these volunteers the organisation could not function.

Description of the Entity's Outcomes:

Bowls Auckland is responsible for the administration, promotion and development of the game of bowls within its defined boundaries. This includes providing support services for its affiliated clubs; events and tournaments for members and visiting participants; and to promote and grow the sport.

Description and Quantification of the Entity's Outputs:

Bowls Auckland has a combined membership and participation base of 47,622 (2024: 44,299). The total number of entries in Bowls Auckland run events was 1,630 (2024: 1,053), for a total of 3,999 participants (2024: 3,364).

Additional Information:

Bowls Auckland was first established in 1896 and in the 24/25 year had 40 affiliated clubs (2024: 40). It covers the area from the Auckland Harbour Bridge in the north to Papatoetoe in the south; from Piha in the west to Maraetai in the east.

1. STATEMENT OF ACCOUNTING POLICIES GENERAL ACCOUNTING POLICIES

The measurement base adopted is that of historical cost. Reliance is placed on the fact that the business is a going concern. Bowls Auckland Incorporated has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses of equal to or less than \$5,000,000. All transactions in the Financial Reports are reported using the accrual basis of accounting. The Financial Reports are prepared under the assumption that the entity will continue to operate in the foreseeable future.

Specific Accounting Policies

The following specific accounting policies which materially affect the measurement of financial performance and financial position have been applied.

(a) Valuation of Assets

Fixed Assets have been recorded at cost less accumulated depreciation.

Listed investments have been recorded at market value (refer notes 4 and 8). Movements in market value of listed investments are reflected in the Investment Revaluation Reserve. Other investments are valued at cost plus accrued interest.

Accounts Receivable have been recorded at estimated realisable value. Where a debt has been considered irrecoverable, it has been written off in the Statement of Financial Performance.

(b) Depreciation of Fixed Assets

Fixed Assets have been depreciated on a straight line basis over the expected life of the asset with the exception of Leasehold Improvements which are being depreciated over the anticipated term of the tenancy lease.

(c) Goods and Services Tax

All amounts are recorded exclusive of GST, except for Debtors and Creditors which are stated inclusive of GST.

(d) Tax

Bowls Auckland is an Incorporated Society and an amateur sports body and has been granted exemption from income tax by Inland Revenue under Section CW 46 of the Income Tax Act 2007.

(e) Leases

Operating lease payments, where the lessors effectively retain substantially all of the risks and benefits of ownership, are included in the determination of the net surplus in equal instalments over the lease term.

(f) Changes in Accounting Policies

There have been no changes in accounting policies during the financial year.

5. RAWHITI PROCEEDS

At an SGM of the Rawhiti Bowling Club (RBC) on 28th September 2014 the members resolved to transfer certain assets (\$5,413,868) to Bowls Auckland Incorporated to establish a Fund to be known as the Rawhiti Fund. The Rawhiti Fund is administered by Bowls Auckland in accordance with the Deed of Agreement made between RBC and Bowls Auckland dated 11th May 2015.

At the same SGM a separate sum of \$1,109,997 was set aside for specific grants to be given to clubs where members of RBC had joined. Bowls Auckland managed these funds on behalf of RBC. Bowls Auckland received an initial fee of \$7,000, plus the ongoing interest whilst the funds remained under Bowls Auckland management. Following distributions to approved clubs the fund balance is \$0.

RAWHITI FUND COMMITTEE REPORT

The Rawhiti Fund provides practical financial support to clubs in our region to carry out facility enhancements and club development.

The Rawhiti Fund continues to be held in term deposits as outlined in the Deed of Agreement, with the risk spread across three banks. There are three funds that make up the Rawhiti Fund: Club Development, Facilities Enhancement and the Covered Green Fund.

The Club is the Hub (CITH) programme entered its second year designed to support the introduction of paid management solutions (club managers) and strategically aligned projects to enable clubs to become sustainable and thrive in a changing world.

2024-2025 saw the Fund enter its 10th financial year. Over this time, the Fund has granted over \$5m to 31 clubs, split across Club Development (\$1.6m), Facilities Enhancement (\$1.3m) and Covered Greens (\$2.25m).

There is currently \$1.7m remaining in the Fund with \$900k committed to ongoing projects due for completion in 2025-2026. Bowls Auckland would like to thank and acknowledge current Committee members; Graeme Bennett (Chair), Ian Dee, Michael Feek, Gerard Hulst, and Allan Smith for their contribution during the financial year.

As the Rawhiti Fund enters its final year, we look forward to providing ongoing support to our club network.




KIMBERLEY INVESTMENT FUND

The Avondale Fund provides practical financial support to eligible clubs in our region to carry out facility enhancements and club development.

The Avondale Fund continues to be held in term deposits as outlined in the Deed of Agreement, with the ASB Bank. There are four funds that make up the Avondale Fund: Club Development, Facilities Enhancement, Legacy and Covered Green Fund. grants distributed, seeing a total of \$227,583.84 awarded with \$177,583.84 paid out. The grants were spread through various funds being Club Development (\$63,333), Facilities Enhancement (\$159,251.84) and Legacy (\$5,000) supporting six clubs. To date no grants have been paid from the Covered Green Fund.
