- Commercial Partnerships continue to increase with the onboarding of JBWere (formally Jarden) as the event partner for the JBWere Auckland Open.
- There is currently a proposed Online Gambling Bill that may impact trust funding availability in the future. Bowls Auckland officially submitted opposing the Bill.
- Bowls Auckland through the leadership of the newly formed Coaches Committee completed the 1 to 5 Year Winter Programme. Through the process, it became relevant an overarching strategic document is required.
- Michael Anderson (Finance Manager) will be leaving Bowls Auckland at the end of November 2025. The Board thanked Michael for his tremendous contribution to Bowls Auckland and the bowling community over his three years of service.
- Acknowledged and thanked staff, and all involved in the delivery of many recent events including Tayla Bruce Masterclass, Molecheck Women's Open, Foundation / Finals Luncheon, President's Day, SGM, and the upcoming Performance Launch.

#### 5.3 Bowls Auckland Foundation

- Since the last meeting, John Slater has joined as a Trustee.
- The Foundation was launched successfully, thanking Royal Oak for hosting, management for delivering and Trustee's for their support.
- The net profit plus raffle revenue from the event will be transferred to the Foundation.
- The 500 Club is gaining momentum, currently with 10 members.

## 5.4 New Lynn Bowling Club

Taken as read with DB highlighting.

- The external accountant has finally finished completing the end of year accounts, and they are with the auditor. This process has been painfully slow, therefore, management are seeking a new external accountant for next year.
- Once the financials are audited, they will be circulated to the Board and members.
- Compared to last financial year at the same point, the club are tracking well, with the following highlights.
  - o Income up 80% mainly due to bar sales, pavilion and green hire.
  - Expenses only up 9% this has managed to be low due to savings on green expenses.
  - o Net profit up 50%.

 The Board congratulated club management, and acknowledged the recent change in club positivity illustrated in representatives attending the BA Foundation Luncheon, and President's Day.

- Further, the Board acknowledged TB for his commitment in support as Vice President.

# 6. Governance Papers

#### 6.1 Bowls Auckland SGM and Constitution

ID highlighted.

- The SGM was successful, with good attendance, and the constitution was unanimously approved.
- The constitution now needs to be approved by the Incorporated Societies Office, once approved, Bowls Auckland will then move to the new constitution, which will mean some actionable changes.
- One change is the disestablishment of the Vice President role which TB currently holds.
   The Board's intent is to co-opt TB on so he can continue his role on the Board at Bowls Auckland.

#### 6.2 Bowls Auckland Facilities Plan

The Facilities Plan was taken as read.

Andy Adams from Visitor Solutions was in attendance and presented the Plan, highlighting the following.

- The Plan illustrates the current state of bowls and facilities, the changing demands, therefore needs of the network in the future.
- Clubs submitted all proposed facility projects, which were filtered through a project criteria list which was assessed by a Steering Group, which populated a project priority list.
- It is recommended that Bowls Auckland seeks to support club projects in a descending manor on the project priority list.
- Support will not always be solely funding, but also lobbying other funders or assisting projects in a bespoke manor to completion.
- It is recommended that the Plan be reviewed and updated on an annual basis to ensure the facility project list remains relevant, changes are included and investment can continue to be strategically directed.

#### Board discussion.

- Thanked Andy and the team at Visitor Solutions for the excellent work in putting the Plan together.
- There was a discussion around certain projects, and their position on the facilities priority list, in which management showed the Board the process of rating each project against the set criteria.

# 7.1 Performance Programme Update

Paul MacKinnon (Performance Lead) presented.

- The philosophy behind performance, is executing a high level skill set, consistently.
- As per the Performance Strategy, Team Management have been working through and completing player depth charts and campaign plans.
- Each of the units have completed the above, and there has been an integrated campaign calendar established.
- The documents will play a vital component this season, assisting selections, tracking players, and ensuring a development and playing programme can be delivered, whilst also setting the baseline for future seasons.

## 7.2 Club Membership Plan

Taken as read, with DB highlighting.

- The Club Membership Plan has been established as an information piece for clubs to adapt and adopt as they see fit.
- It aims to simplify membership categories, simplify the joining / application process, encourage membership (of any kind), support the transition from social (or limited) to full, transition the membership process onto digital platforms (along with the renewal process) and for clubs to expand offerings, therefore value to current and future members.
- It is founded on the belief that everyone who enters a bowling club should be offered a membership, and that all members should have access to bowls.
- Bowls Auckland's role is to assist clubs in moving over to digital platforms, lobbying Bowls New Zealand for simplification in the 'official' membership categories and to consider changes to the current membership fee model.

# 7.3 Club Re-Registering Update

Taken as read, with DB highlighting.

- 23 clubs have completed the process, with four more awaiting SGM's, and six currently in the drafting stage.
- That leaves six further clubs who have not yet given an update, and may require more assistance.
- To have 33 clubs either completed the process, or close to is a fantastic position to be in, and the Board thanked Bowls New Zealand for their contribution.
